3. Mexico has been one of the top performers during the last 10 years within the Latin American markets.

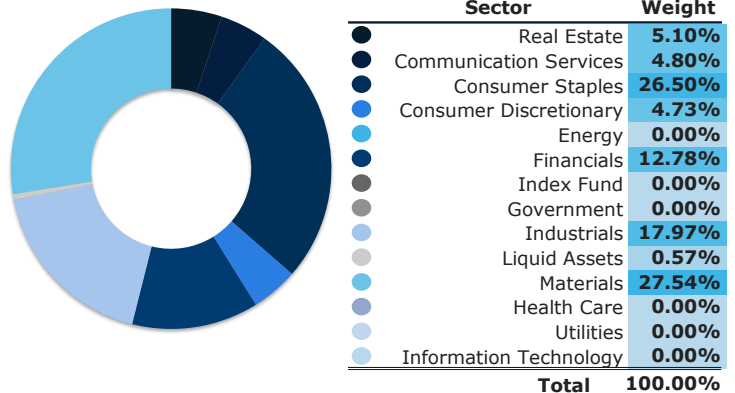

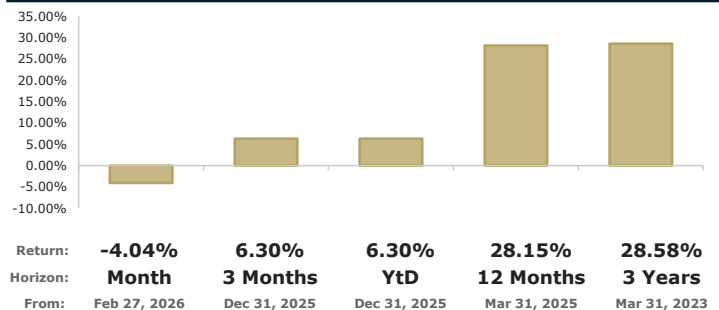
