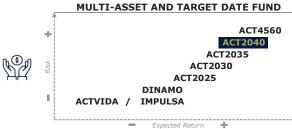

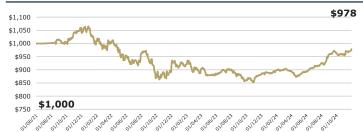


#### ASSET CLASS BREAKDOWN<sup>1</sup>
