3. This stock market index has been one of the top performers during the last 10 years.

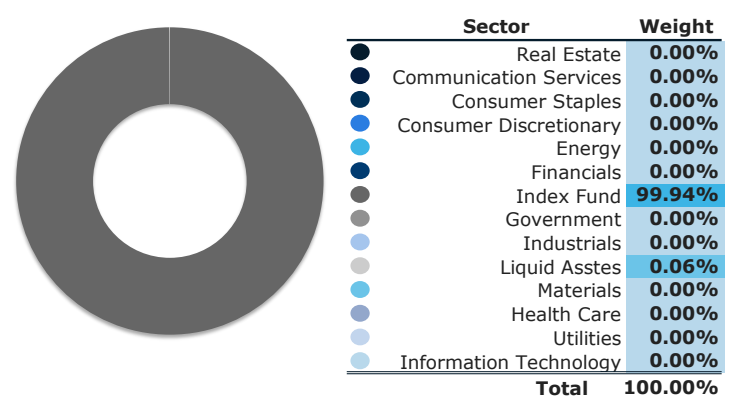

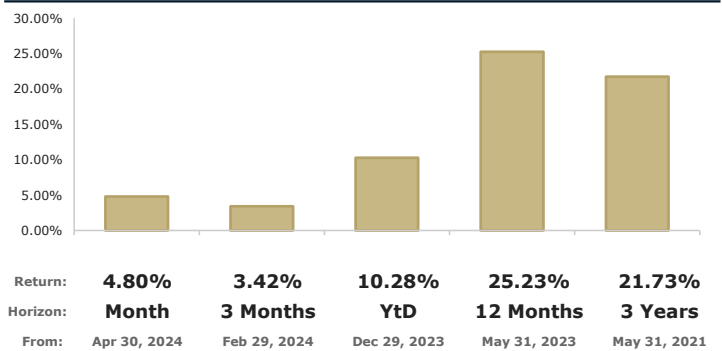
