The fund invests mainly in Local Corporate Debt denominated in MXN.

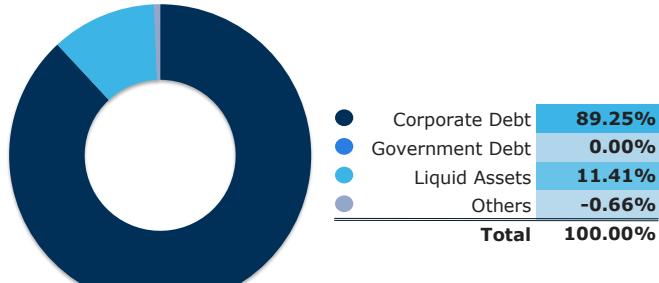
FUND KEY ASPECTS

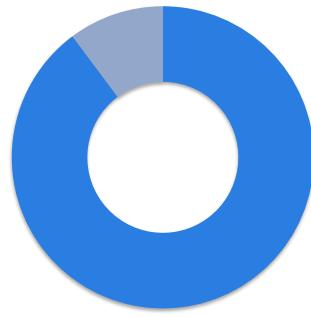
