FUND KEY ASPECTS



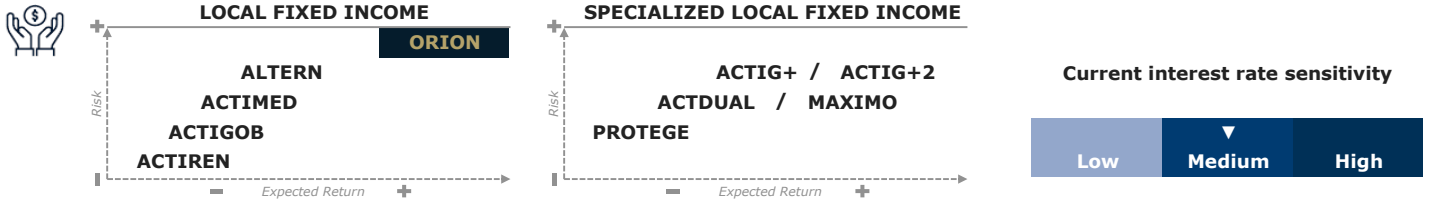
1. The Fund objective is capital growth in the long-term (at least 6 months)

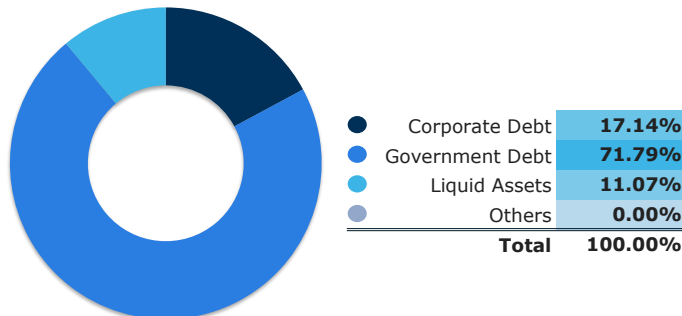

ASSET CLASS BREAKDOWN¹

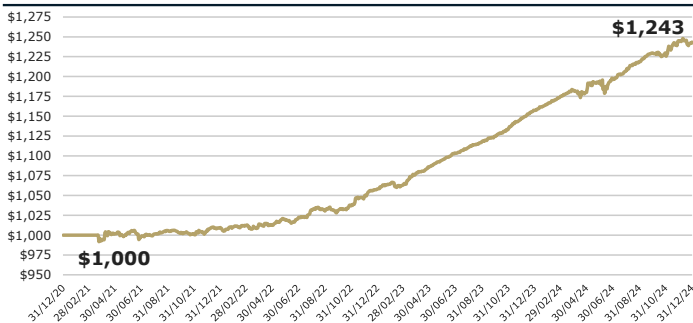

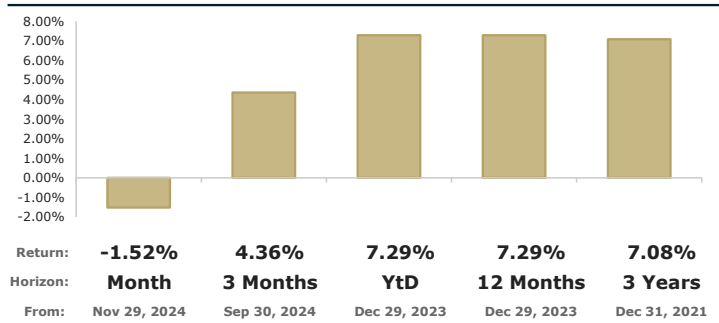
CURRENCY BREAKDOWN¹
