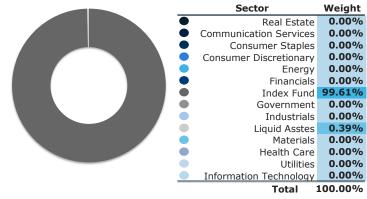

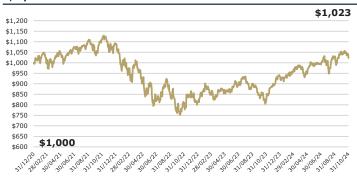

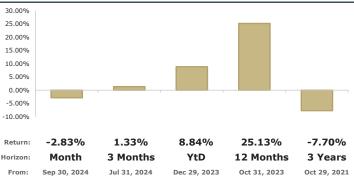
GROWTH OF HYPOTHETICAL \$1,000.00 USD²
