Terms and Conditions Governing the Use and Access to this Portal

The terms of the agreement governing the relationship between you (the User) and Banco Actinver, S.A., Institución de Banca Múltiple, Grupo Financiero Actinver; Actinver Casa de Bolsa, S.A. de C.V. Grupo Financiero Actinver; Operadora Actinver, S.A. de C.V. Sociedades Operadora de Sociedades de Inversión, Grupo Financiero Actinver; Arrendadora Actinver, S.A. de C.V., Actinver Insurance Services Agente de Seguros y de Fianzas; S.A. de C.V., and any entity that is a member, subsidiary, related party, dependent, or affiliate of Corporación Actinver, S.A.B. de C.V., and/or Grupo Financiero Actinver S.A. de C.V. (hereinafter referred to as "Actinver"), when accessing, browsing, or using this website, are outlined below. These Terms and Conditions of Use are in addition to any agreement you have with Actinver.

Acceptance of Terms, Conditions of Use, and Privacy

Please read these Terms and Conditions of Use carefully. By simply using or accessing any of the pages comprising Actinver's Portal (hereinafter referred to as the "Portal"), it is understood that you have read, accept, and agree to be bound by the terms and conditions described herein; otherwise, refrain from using the Portal.

For the purposes of these Terms and Conditions of Use and Access, the term "Portal" shall include all resources and assets owned or under the control of Actinver, subdomains and subdirectories, and all Internet guides developed in whole or in part by Actinver that display or transfer information to or from any electronic device, including but not limited to personal computers, mobile phones, personal digital assistants, and television equipment.

The definition also includes the external appearance of screen interfaces, both static and dynamic, as well as the elements integrated within these screen interfaces, such as the navigation tree, including, but not limited to, trademarks, logos, trade names, patents, industrial designs, characters, texts, images, sounds, databases, multimedia products, artistic performances, photographs, broadcasts, and all other creations and objects expressed by any medium or support, whether or not they are subject to protection under intellectual or industrial property law or any other analogous legal systems.

Security Measures

The User understands and consents that:

- ACTINVER is authorized to adopt the security measures it deems appropriate regarding the Electronic Systems, Electronic Signature, and communication related to Banking Services. By agreeing to these terms, the User explicitly accepts the security measures chosen and applied by ACTINVER.
- As a financial institution regulated by the Ministry of Finance and Public Credit, Actinver is
 required to collect data and information from the User to comply with applicable legal
 provisions regarding the prevention and detection of acts, omissions, or operations that could
 facilitate, assist, or provide support of any kind for the commission of crimes outlined in Articles
 139 or 148 Bis of the Federal Penal Code, or that may fall under the provisions of Article 400 Bis
 of the same Code.
- Actinver does not request confidential data via email.
- As a User, you must use secure passwords consisting of at least 8 alphanumeric characters (including symbols and numbers) and periodically change your email access password.
- Avoid accessing your accounts in public places or on shared-use computers.

Technical Access Requirements

To access the Portal, the User must have Internet access, either directly or indirectly through access devices, and possess the equipment and computer systems necessary to establish an Internet connection, including a terminal suitable for this purpose and an access device. To correctly access and utilize certain content and services on the Portal, the User may need to download specific software or other logical elements onto their devices.
